INFORMATION REGARDING THE PROCESSING OF PERSONAL DATA

(ART. 13 REG. EU 2016/679) GDPR

For the purposes envisaged by the aforementioned EU Regulation 2016/679, containing the new provisions for the protection of "privacy" and relating to the protection and processing of personal data, you are hereby informed that the processing of personal data already provided by you and acquired to date, as well as that which will be provided, will be processed in compliance with the regulations set forth in the aforementioned Regulation and the obligations of confidentiality and transparency to which the data collector is bound.

1) Data processor

The data processor is the Federation of Protestant Churches in Italy FCEI whose whose headquarters are in Rome at Via Firenze, 38; - P.Iva 01030141004 and whose legal representative is Daniele Garrone C.F. 02090430584

2) Purpose of data processing

According to Art. 6 EU Regulation 2016/679

Personal data provided are necessary for the following purposes:

- execution of a contract to which the subject is party and execution of precontractual measures adopted at the request of the same.
- processing is necessary to discharge a legal obligation to which the data processor is subject;
- processing is necessary to safeguard the vital interests of the subject or another natural person;

Data processing is reserved for pursuit of the legitimate interests of the data processor or third parties, in full respect of the interests, fundamental rights and freedoms of the data subject requiring the protection of personal data, in particular if the subject is a minor.

3) Data processing and storage

Processing of data provided by you is carried out in either an automated manner and/or manually according to regulations outlined in Article 32 of G.D.P.R. 2016/679, by specifically assigned individuals and in compliance with the provisions of Article 29 of G.D.P.R. 2016/679. We advise that, in compliance with principles of lawfulness, purpose limitation and minimsation of data, pursuant to art. 5 GDPR 2016/679, following your freely-given express consent, expressed at the foot of this document, your data will be stored for the period of time required to accomplish the purposes for which the data have been collected and stored.

4) Scope of data communication and dissemination

We further inform you that sensitive data regarding ethnicity, political opinions, religious and philosophical convictions, health and sexual orientation will be gathered. The data collected will not be disseminated or communicated without your explicit consent, except in the event of required communication which may entail transfer of data to public authorities, consultants or other parties in order to fulfill legal obligations.

Additionally, the aforementioned data may be released, within the limits of the law, to authorized employees and/or may be made available to relevant partner associations expressly named and appointed by the data processor.

5) Rights of the data subject

At any point, pursuant to Articles 15 to 22 of EU Regulation No. 2016/679, you may exercise your right to:

- request confirmation of the existence or absence of your personal data;
- obtain information regarding the purposes of data processing, recipients or categories of recipients to whom that data is communicated and , where possible, the data storage period;
- data correction and removal;
- The right to obtain information regarding data analysis regulation and limitations;
- The right to obtain raw data from the data controller, without any hindrance in an accessible, organized and legible format, and the right to release the data to a separate entity for data evaluation;
- request of the data processor access to personal data and correction or erasure of the same as well as the right to request restriction or to object to processing beyond the right to portability of data.
- revoke consent at any time without prejudice to the lawfulness of processing based on previous authorization given;
- file a complaint to the controlling authority.

(g) Exercise of rights
